The Ministry of International Cooperation (MoIC) has received financing from the International Bank for Reconstruction and Development (IBRD) (the "Bank") in the form of a loan (hereinafter called "loan") toward the cost of Strengthening Social Safety Net Projects (SSSNP). The Ministry of Social Solidarity (MoSS), an implementing agency of the Client, intends to apply a portion of the proceeds of this loan to consulting services.

Also, conduct TOT for the personnel that will be required to pass on their knowledge to others involved in the process.
